Agenda Item A-5 Special Event Application – Oklahoma at Trapps

Summary: Trapp Family Lodge has submitted a special event application for Oklahoma in Concert, by the Lyric Theatre, the Flynn and the Vermont Symphony Orchestra. The concerts will be between 5:30 PM – 9:30 PM (music starting at 7:03 PM) on August 13-15. They anticipate between 600-700 attendees for each concert. Parking will be on the gravel lot at the outdoor center, as well as the grass lot southeast of the outdoor center wedding meadow. Stowe PD and EMS historically have not provided coverage for this event. They will have a beer and wine tent with food options.
